

## Post Basic Specialty Course Bursary

Bursaries valued up to \$1000 are awarded annually to assist RNs to complete a continuing education course or program that will enhance their nursing practice. Specialty certification exams (other than CNA) are also eligible for this bursary.

### NOTE: THIS IS NOT AN APPLICATION FORM

You will be required to provide the following information on your application:

#### A. Personal Information

- Contact information (Name, E-mail\*)
- ARNNL Registration Number **\*REQUIRED**
- Social Insurance Number (Required for [Income Tax](#) purposes)
- Length of time living in NL
- Previous Trust Conference and Post Basic Course bursaries and year received

#### B. Employment Details

Employment details are used to demonstrate the relevance of the program/event to your nursing practice.

- Employer – RHA, Educational Institution, Private/Self Employed, Other
- Site (e.g., St. Clare's Mercy Hospital)
- Position
- Area of Responsibility/Specialty Area **\*REQUIRED**

#### C. Course/Program/Certification Details

- How the course/certification relates to your nursing practice (checkboxes) **\*REQUIRED**
- Application for: single course, diploma/multi-course program, certification exam **\*REQUIRED**
  - Single Course: title, offered by, start date, end date, currently registered/enrolled
  - Diploma/Multi-Course Program: title, offered by, start date, end date, number of courses in program, currently registered/enrolled
  - Specialty Certification Exam: certification, offered by, exam date, currently registered

#### D. Budget

- Costs – include eligible costs (with applicable taxes)

  - o Total Cost
- Other Sources of Financial Assistance
  - o Funding source and amount of any funding you have applied for or received to date to assist with the costs of the program/event and whether the funding has been approved.

#### Important Notes:

- If your application is successful, you will be required to submit **verification of eligible costs** (e.g., receipt for tuition and/or exam fees) and **proof of attendance** (for conferences) or **proof**

**of successful completion** of the course/program/certification exam in order to claim your bursary. Any additional documentation requirements will be outlined in the notification email you receive from the Trust.

- If you are successful in achieving **full funding** from other sources, you will be asked to accept the other funding. If you receive notification that you have received full funding after you have received your bursary from the Trust, you are ***required to notify the Trust and return the Trust funds.***
- Deadline for receipt of applications:
  - **April 15<sup>th</sup>** for CE events between **January and June.**
  - **October 15<sup>th</sup>** for CE events between **July and December.**
  - Unless otherwise stated on the Trust website, applications for CE events outside of the specified timeframe **will not** be accepted (e.g., applications for leadership events between January and June will not be accepted in the fall competition).
